**RESOLUTION NO. 19-268**

**A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF PASCO COUNTY, FLORIDA, ADOPTING THE FINAL LEVYING OF AD VALOREM TAXES FOR PASCO COUNTY FOR FISCAL YEAR 2020; PROVIDING FOR AN EFFECTIVE DATE.**

**WHEREAS**, the Board of County Commissioners of Pasco County, Florida, on September 18, 2019, adopted Fiscal Year 2020 Final Millage Rates following a public hearing as required by Florida Statute 200.065; and,

**WHEREAS**, the Board of County Commissioners of Pasco County, Florida, held a public hearing as required by Florida Statute 200.065; and,

**WHEREAS**, the gross taxable value for operating purposes not exempt from taxation within Pasco County has been certified by the County Property Appraiser to the Pasco County Board of County Commissioners as \$29,523,620,128.

**NOW, THEREFORE, BE IT RESOLVED** by the Board of County Commissioners of Pasco County, Florida, that:

1. The Fiscal Year 2020 operating millage rate is 7.6076 mills, which is greater than the rolled-back rate of 7.4405 mills by 2.25%.
2. The voted debt service millage for the 2019A Bonds – Jail Project is 0.0277 mills.
3. The voted debt service millage for the 2019B Bonds – Fire-Rescue Projects is 0.0222 mills.
4. The voted debt service millage for the 2019C Bonds – Parks and Recreation Projects is 0.0100 mills.
5. The voted debt service millage for the 2019D Bonds – Libraries Projects is 0.0096 mills.
6. The transportation millage is 0.0000 mills.
7. The Pasco County Municipal Fire Service Unit millage is 1.8036 mills, which is greater than the rolled-back rate of 1.7126 mills by 5.31%.

8. This resolution will take effect immediately upon its adoption.
