**PUBLIC NOTICE**

The Federal Emergency Management Agency and Florida Division of Emergency Management have received the following application for Federal grant funding. Final notice is hereby given of the Federal Emergency Management Agency's (FEMA) consideration to provide funding in the form of a Flood Mitigation Assistance Program Grant.

Under the National Environmental Policy Act (NEPA), federal actions must be reviewed and evaluated for feasible alternatives and for social, economic, historic, environmental, legal, and safety considerations. Under Executive Order (EO) 11988 and EO 11990 FEMA is required to consider alternatives to and to provide public notice of any proposed actions in or affecting floodplains or wetlands. EO 12898 also requires FEMA to provide the opportunity for public participation in the planning process and to consider potential impacts to minority or low-income populations.

Funding for the proposed project will be conditional upon compliance with all applicable federal, tribal, state and local laws, regulations, floodplain standards, permit requirements and conditions.

**Project Title:**

**Location of Proposed Work:**

The Residents on Bellview Ave and Cotee River Dr. may experience minor traffic disruptions due to the elevation of the property.

**Proposed Work and Purpose:**

The proposed project will consist of elevating the current structure above Base Flood Elevation in compliance with all applicable local, state, and federal codes, including compliance with ASCE 24-05.

**Project Alternatives:**

**DEPARTMENT OF EMERGENCY MANAGEMENT**

The alternatives to the project that have been and will be considered are: 1) The no action alternative, and 2) Mitigation Reconstruction. These alternatives to the proposed project are not viable because under Alternative 1) the homeowner would remain susceptible to flood damages; and under alternative 2) the homeowners would be required to abandon their home and they wish to remain on the property.

**Comment Period:**

Comments are solicited from the public; local, state or federal agencies; and other interested parties in order to consider and evaluate the impacts of the proposed project. The comments should be made in writing and addressed to the Florida Division of Emergency Management, Bureau of Recovery and Mitigation, 2555 Shumard Oak Blvd., Tallahassee, FL 32399-2100. These are due within 30 days of this notice. The State will forward comments to applicable regulatory agencies, as needed.
