



## PUBLIC HEARING FOR PASCO COUNTY'S AFFORDABLE HOUSING ADVISORY COMMITTEE

Pasco County's Affordable Housing Advisory Committee (AHAC) will hold a public hearing April 13, 2021, at 9:00 AM at the West Pasco Government Center, Board Room, 8731 Citizens Drive, New Port Richey, FL 34654.

The Affordable Housing Advisory Committee (AHAC) is responsible for reviewing policies, land development regulations, the Comprehensive Plan Policy, and other aspects of the County's policies and procedures that affect the cost of housing. In addition, the AHAC is responsible for making recommendations to encourage affordable housing. The AHAC will approve a report to the Board of County Commissioners with recommendations on each the 11 strategies as required by Florida State Statute 420.9076.

This hearing will be held as a HYBRID VIRTUAL MEETING with a quorum of committee members physically in attendance, and other committee members and County staff attending in person or participating through video conferencing, consistent with the requirements of Resolution No. 20-182.
