Failure to follow these rules may result in disciplinary action and/or loss of visitation privileges. Visitation suspensions may be implemented in a progressive disciplinary manner, as deemed appropriate for type of violation. Suspensions may range from a 3-day suspension to a lifetime suspension. Suspensions may be applied to the inmate and/or the visitor.

Inmates and Visitors must adhere to the following rules:

- While conducting a visit onsite, visitors are subject to search for admittance into the facility. Introduction of contraband into a correctional facility is a felony of the 3rd degree (F.S.951.22).
- All participants must conduct themselves in an orderly manner. Visitors who are unruly and using obscene language will be asked to leave the facility for local visits and the visit will be terminated.
- No smoking is permitted in the facility to include lobby/visitation.
- Visitors will be responsible for their children during local visits. If children become disruptive, the visitor will be directed to leave the facility. Minor children will not be left in the lobby or visitation room without adult supervision.
- Visitors must place all property (cell phones, keys, wallets, sunglasses, hats, jackets, etc.) in the secured lockers provided in the lobby. No items are allowed in the visitation room.
- Onsite visitation is limited to 3 visitors at a time. Only the scheduled inmate may engage in the visit.
- Children must be age appropriately clothed and accompanied by an adult.
- All participants must be appropriately dressed during the visit. No nudity, to include the exposure of breasts, nipples, genitalia, pubic areas and buttocks. Visitors must be dressed in accordance with the facility dress code while on site.
- Inmates and visitors must use only their visitation account. Use of an account other than their own will result in disciplinary action for the inmate and suspension for the visitor.
- Visitors must be 18 years of age or older. Any visitor under the age of 18, unless emancipated by the court as an adult, must be accompanied by an adult. Proof of emancipation required prior to visitation account approval.
- Participants must show their face on screen at all times.
- No sexual conduct/activity is permitted, to include the display of sexually oriented materials.
- No firearms or weapons may be displayed during the visit.
- No display, use, or manufacturing of illegal substances. Individuals appearing under the influence of substances while at the facility may be asked to leave and the visit cancelled.
- No display of any photos or videos during the visit. This includes videos, photographs, screenshots or documents displaying text of any kind, to include, but not limited to: internet pages, news clippings, articles, printouts, materials from social media, emails, test messages or similar content.
- No recording or taking photos of the visit.

- No hand signals may be used except for those of a recognized sign language, such as American Sign Language.
- No display of any written messages/materials in code or an unrecognizable language.
- No display of any personal information about another inmate or offender, or any information that could threaten safety and security of the facility.
- No threats, discussion and/or planning of committing a crime.
- No promotion of animosity, hostility, and/or malice against a person or persons, or against the property of a person or persons, based upon race, religion, disability, sexual orientation, ethnicity or national origin.
- No 3rd party calls, to include video calls, speaker phone, etc.
- Inmate's may not participate in an unauthorized interview, to include both formal and informal interviews.
- Participants must engage in lawful behavior. Individuals observed engaging in any behavior defined as a misdemeanor or felony crime will be reported to the authorities and participants subject to loss of visitation privileges.

Notes:

- There are times when access to the facility will be denied for security reasons.
- The above rules pertain to all inmates and visitors. Violators may be refused visitation.
- The rules and regulations for visitation may be changes, at any time, for security purposes.
- Local and virtual visits can be cancelled at any time for security issues.
